NOTICE OF PERSONAL GUARANTY

Each undersigned guarantor binds himself jointly, severally and in solido with customer and all other guarantors for the full, faithful, and timely execution of and compliance with all of the obligations, conditions, and stipulations assumed or agreed to by successors and assigns, the payment of all amounts due to Scurlock Electric LLC. Without limiting the foregoing, guarantor does hereby unconditionally guarantee to Scurlock Electric LLC, it's successors and assigns, the payment in full of any and all amounts and indebtedness, direct or contingent, arising out of, related to or connected with customer's obligations to Scurlock Electric LLC in addition to all interest, attorney's fees, costs, and expenses suffered or incurred by customer.
